Data protection / Privacy Rights / NIL

(1) The "Panda Lacrosse Club" collects, processes and uses the personal data of its members (personal and current information) via electronic data processing (EDP) for the purposes of fulfilling tasks permitted under this statute. (2) As a member of the Deutscher Lacrosse Verband (DlaxV), the club is obliged to provide certain personal data such as; name and age of members a e-mail addresses to create a player pass. If a player does not have a player pass that individual is not allowed to participate in DlaxV sanctioned matches.

(3) Within the framework of the statutory provisions of the Federal Data Protection Act (in particular §§ 34 and 35 BDSG), each member has the right to information regarding the personal data stored, recipient of the data, purpose of the storage as well as any modification, deletion or blocking of personal data. The right to object to the processing of personal data in accordance with § 36 BDSG can be exercised by any member at any time.
